The Hate Crimes Unit in the Office of the New York State Attorney General's <u>Civil Rights Bureau</u> seeks a civil rights litigator to fight hate and violent extremism and protect civil rights from abusive technologies. The attorney will serve in the Hate Crimes Unit in the New York City office.

The Civil Rights Bureau enforces federal, state, and local laws that protect New Yorkers from hate, bias, and discrimination on the basis of race, color, national origin, ethnicity, gender, gender identity, religion, age, marital status, sexual orientation, military status, source of income or disability. The Bureau engages in significant community outreach, public education and other advocacy efforts.

Qualifications for this position include the following:

- A minimum of three (3) years of post-graduate legal experience with a focus on civil litigation, including discovery and motion practice is preferred, but the bureau will consider well-qualified applicants with fewer years of experience;
- Excellent oral advocacy, legal analysis and legal writing and editing skills;
- Experience working with communities targeted by hate and bias;
- Strong organizational, interpersonal communication, problem solving and teamwork skills: and
- Experience investigating, litigating and engaging in policy advocacy regarding hate, bias, violent
