Speakers:

Jacqueline P. Flug, Esq. has served as General Counsel and Senior Vice President at Drizly, as General Counsel and Vice President of Roosevelt Island Operating Corporation, and as General Counsel to the New York State Liquor Authority. Prior to her tenure at the Authority, Jaci served as Administrator of the Assigned Counsel Plan for the Appellate Division, First Department and began her legal career as an Assistant District Attorney in Bronx County focusing on violent felonies and vehicular homicides. Ms. Flug served as the President of the Women's Bar Association of the State of New York (WBASNY) from 2016-2017 and the President of the Bronx Women's Bar Association from 2007-2008. She serves on various Court Committees, including the Judicial Hearing Officer Screening Committee for the Appellate Division, Second Department and the Central Screening Committee for the Appellate Division, First Department. Ms. Flug proudly served as a coach for Bronx Middle School I.S. 145 in the Thurgood Marshall Junior High School Mock Trial Competition and served on the Board of the National Organization for Women – NYC. Ms. Flug has been a member of JALBCA since 2005, serving on many committees, and was the Co-President of JALBCA from 2020 to 2022. Ms. Flug received her Juris Doctor cum laude from New York Law School and her B.A. in American Studies from SUNY Geneseo and admitted to practice law in 2002.

Professor Brad Wendel, the Edwin H. Woodruff Professor of Law, at Cornell Law School, is a leading expert on the law governing lawyers. He is a member of the Multistate Professional Responsibility Exam drafting committee, lectures around the world on legal ethics and professional responsibility law, and has authored over 50 books and articles in the area. Brad joined the Cornell faculty in 2004, after teaching at Washington and Lee Law School from 1999-2004. He began his career litigating products liability matters for a large firm in Seattle, WA after clerking for Ninth Circuit Court of Appeals Judge Andrew J. Kleinfeld. Brad has a J.S.D. from Columbia University, a J.D. from Duke Law School and a B.A. in Philosophy from Rice University, and was admitted to practice in the Courts of the State of New York in 2011.

Mariette Geldenhuys, Esq. has practiced law in Ithaca, New York for over 30 years, in areas including family and matrimonial law; lesbian, gay, bisexual and transgender (LGBT) family law; estate planning, adoption, small business advising, and municipal law. Several years ago, she shifted the focus of her practice to collaborative law and mediation, to help clients resolve legal issues in a respectful, client-centered way and without litigation. Mariette received her undergraduate and graduate law degrees (BLC and LLB) *cum laude* from the University of Pretoria, South Africa, where she received numerous academic awards. She studied law and criminology at Oxford University as a Rhodes Scholar. She was admitted to practice in New York in 1989, and holds admission in the Supreme Court of Gauteng, South Africa and the Northern District of New York. Mariette is the Founder and Founding President of the Ithaca Area Collaborative Law Professionals. She was one of the four attorneys who represented the "Ithaca 50" pro bono in the action seeking marriage equality for same-sex couples in New York. She is a member of the National Family Law Advisory Council of the National Center for Lesbian Rights and the New York State Bar Association Committee on LGBT People and the Law. She is a member of the National LGBT Bar Association and a member and past president of the Tompkins County Bar Association. Mariette is a frequent lecturer on issues related to collaborative law and LGBT family law, including at the Annual Forum of the International Academy of Collaborative Professionals, Cornell Law School, the New York State Bar Association, the Family Law Conference in Cape Town, South Africa, the Family Law Institute of the National LGBT Bar Association and the New York State Council on Divorce Mediation. She has presented collaborative law training in several states in the United States and in Canada.
