The Attorneys Bureau, one of the largest within the OAG, offers a diverse and stimulating practice with attorneys handling all phases of litigation from inception through trial. This position provides an excellent opportunity for both experienced and newer attorneys to Investigators continue developing their litigation and trial skills. The HHSPG is comprised of three (3) Sections that principally **Other Professional &** represent: **Legal Support Positions** 1. the State's public health agencies, including the Department of Health, the Office of the Medicaid Inspector General, and the Office of Professional Medical Conduct; Law Students 2. the State's mental health agencies, including the Office of Mental Health, the Office for People with Developmental Disabilities, and the Office of Addiction Services and Supports; and **Undergraduate &** 3. the State's social service agencies, including the Office of **Graduate Students** Temporary and Disability Assistance, the Department of Health, and the Office of Children and Family Services Fellowship & Volunteer Attorney Opportunities

Attorneys are assigned to a Section within the HHSPG. and each Section is led by a Section Chief and a Deputy Section Chief. This structure affords attorneys significant access to and support from supervising attorneys, as well as opportunities for collaboration with peer attorneys, all while independently defending complex cases in federal and state court. HHSPG attorneys participate in all phases of litigation from inception to trial and frequently appear in court. HHSPG attorneys also engage in significant motion practice, often addressing issues of first impression in challenges to state statutes, regulations, and policies related to such complex social issues as vaccination requirements, First Amendment rights, physician discipline, child welfare, ADA integration mandates, and access to medical treatment and social services. HHSPG attorneys work on a number of class actions and complex litigations concerning challenges to important governmental programs in these areas as well.

Suitable candidates must possess the following minimum qualifications:

- At least **three (3) years** of post-graduate civil litigation experience in federal and New York state courts;
- Excellent legal analysis, legal writing and editing, and oral advocacy skills;
- Strong organizational, interpersonal communication, problem solving, and teamwork skills;
- Comfort with and proficiency using technology to complete legal work, including knowledge of and experience with various computer software programs and case management and electronic discovery platforms; and
- Prior complex litigation and trial experience are preferred, but not required.

Applicants must reside in (or intend to soon become a resident of) New York State and be admitted to practice law in New York State. **Prior admission, or eligibility for admission, to the United States District Courts for the Southern and Eastern Districts of New York is also required for this position.** In addition, the Public Officers Law requires that OAG attorneys be citizens of the United States. A two (2) year commitment upon being hired is a condition of employment.
