Chief Judge Wilson Announces Series of PSAs Encouraging Participation in Jury Service

NEW YORK—In recognition of the crucial role juries play in our democracy, and in ensuring justice, Chief Judge Rowan D. Wilson today announced that throughout November the New York State Unified Court System will roll out a series of Public Service Announcements (PSAs) encouraging participation in jury service. The PSAs, which feature individuals from a broad cross-section of our community, underscore the importance of jury service and advise how you can volunteer to be a juror instead of waiting to be called.

“Typically, the week before Thanksgiving is Juror Appreciation Week, but this year the whole month of November is Jury Appreciation Month,” said Chief Judge Wilson. “Jurors—citizens from all walks of life and all backgrounds—are crucial not just to our system of justice but stand as a bulwark that preserves our democratic institutions. Only if all participate can we attain the goal of our Founders in providing a jury of we, the people.”

Each of the 16 PSAs was filmed and produced by Youth FX, through the south end Albany-based organization’s full-service production company, Rogue FX, which offers young people professional on-set experience in digital film and media. Those who graduate from Youth FX programs are offered the opportunity to work on Rogue FX productions and be mentored by their team of experienced filmmakers. In addition to the PSAs, Youth FX/Rogue FX this year produced new orientation films for individuals reporting for petit (trial) or grand jury service. Those films, which will be shown to approximately one million individuals annually in every county of the state, are available on the court system’s YouTube channel (grand jury: <https://youtu.be/Hn2YsmGq3Fs>; petit jury, <https://youtu.be/Biauu4qhK3c>).

More than two dozen individuals—including judges, court personnel and private citizens—appear in the various films.

“I am deeply appreciative that so many people, from inside the court system and from the community at large, so eagerly and patiently participated in the filming. I am also grateful that Youth FX used the production of these PSAs to train and inform a young generation of aspiring filmmakers,” said Chief Judge Wilson.

Rashid Howell, co-founder and technical director of Youth FX, said partnering with the court system has not only provided young people with an opportunity to apply the skills they learned in the program, but also to fully appreciate the importance of jury service in our system of justice.

“Through this partnership, we have been able to put a dozen of our alums to work on the jury and juror productions, giving them the chance to travel across the state, visit courtrooms, meet judges and gain insight into the workings of our judicial system,” said Howell. “The experience is invaluable, and we are very grateful to the court system and Chief Judge Wilson for entrusting Youth FX/ Rogue FX with this important initiative.”
